Brief Details.

On the 23/11/2021, I was along corporation road, heading towards boon lay place, I was at the filter lane waiting for car to pass. Suddenly a van(GBH4168H) collided on my rear from behind. I leaned forward and fell onto the ground. The bike fall and toppled onto my left leg. The van driver call for ambulance. Shortly, ambulance arrived and then conveyed me to Ng Teng Fong Hospital. I was given 23 days of Medical leave and I was discharged on the 24/11/2021, at 1000hrs. The doctor said that the accident had damaged my nerve on my leg and told me to observe.

Siti Norhafidah from the traffic police contacted me and told me to make a police report. I wish to state that I was having pain on my left leg, thus I delayed my reporting of this accident.
