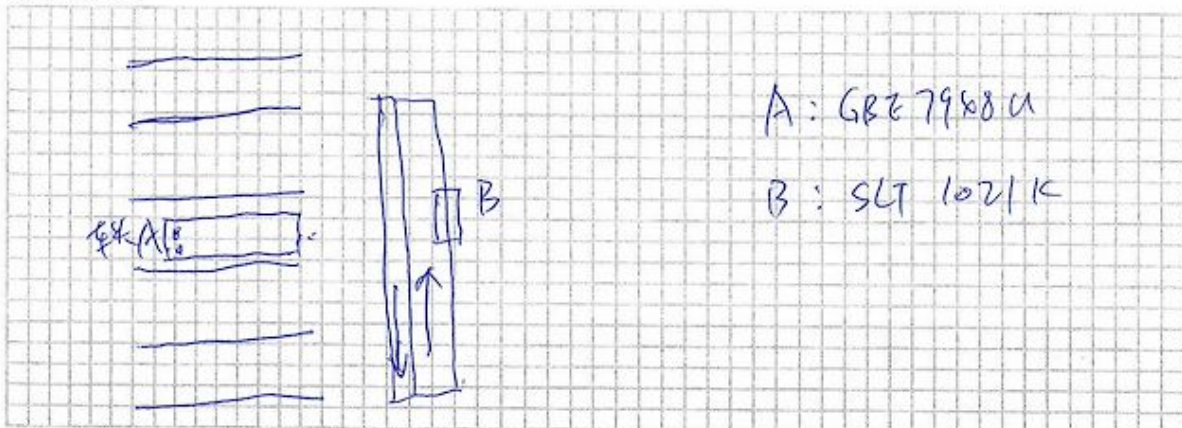

There was a car parked at my back right hand behind. However I didn't notice the car was there when I reversed my van that time. So I hit the door of that car at the end.




