Brief Details.

I am the vehicle commander for MID 35561 driven by REG Davy Koh. We were travelling on PIE just before Exit 35 when our vehicle broke down. Our vehicle broke down on Lane 2, 100m before PIE(Changi) as we were on the way to Clementi Camp from Pasir Labar Camp. We dismounted the vehicle and went to the centre divider of the highway as the traffic was very heavy and it was unsafe to be in the vehicle. I called for EMAS Recovery to inform of our breakdown. While waiting for the EMAS Recovery to arrive, a Cement Truck (WCS045T) collided into the left rear of my Command Jeep. Upon impact, my command jeep moved into lane 1 and the cement truck swerved to the 3rd lane of the highway. I went to check if there was any injury to the cement truck driver. Shortly after, AETOS and EMAS Vehicle arrived and took over the management of the incident. There was no injury to all personnel involved. This is all I have to say.
