Brief Details.

I am serving National Service Full-Time posted to Khatib Camp as a driver. I am holding Singapore Armed Forces Driving Permit for Class 3 and Class 4.

On 31/07/2020, I was driving Singapore Armed Forces car, one green Ford Everest (vehicle no. MID34081). I was supporting the National Day Parade Mobile Column from Khatib Camp to Tuas South.

Around 2125hrs, I was stationary at the traffic light junction of Sembawang Road turning right on to Mandai Avenue. I was on the second lane. When the traffic light turned green, I proceeded to move off but my vehicle rolled backwards and hit on to a rear civilian lorry, one white Isuzu (vehicle no. YP6256J).

I stopped and exchanged particulars with the lorry driver, Zhang Qijun (FIN: [REDACTED]) from Z&Z logistics Pte Ltd).

No one was injured in the collision. Due to the collision, the car I was driving sustained scratches at the rear tow jaw. The lorry sustained a small dent on the front bumper.

I am lodging this report for my own record and SAF action.
