

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

My car was parked vertically outside the shop (42 motors), I was given the all clear sign by the owner of 42 motors that I could move out. Prior to moving off, I perform my due diligence of checking my blind spot for any incoming vehicles. I saw no car approaching and there was a white Honda Civic (SGY 6236 H) on my right blocking my view. As a result, I made careful small movements rather than dashing out of my parking lot. The next moment I saw a lorry (G1E 4531 H) approaching at very high speed, way above the speed limit of 15 km/h of the compound. I performed emergency brake, however, as the lorry was travelling too fast he could not brake in time, thus, colliding into my vehicle.
