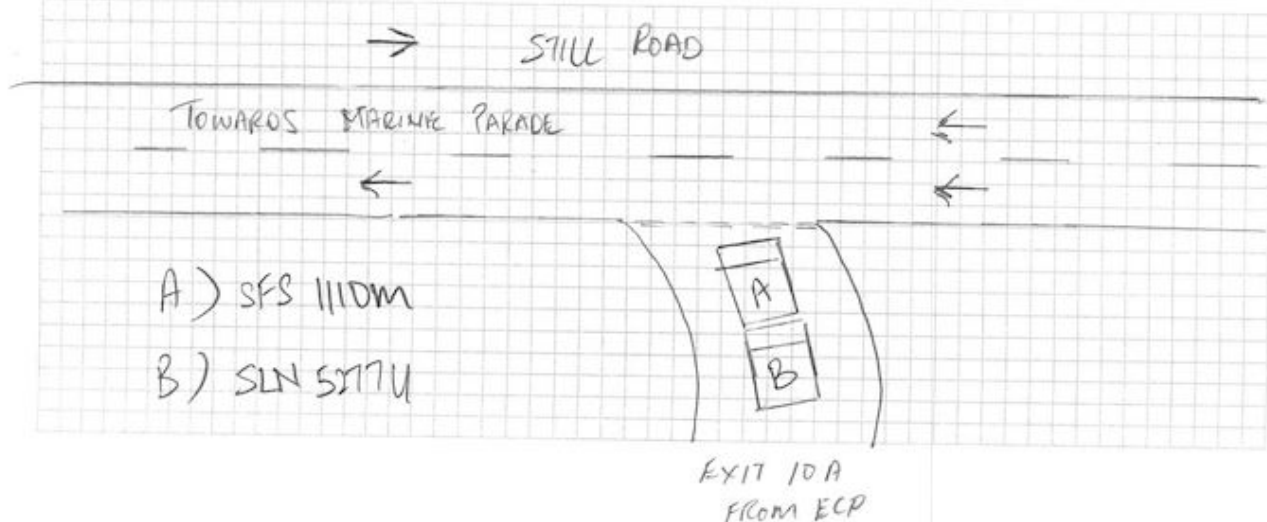

**Describe Circumstances of the Accident**

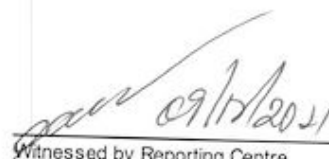

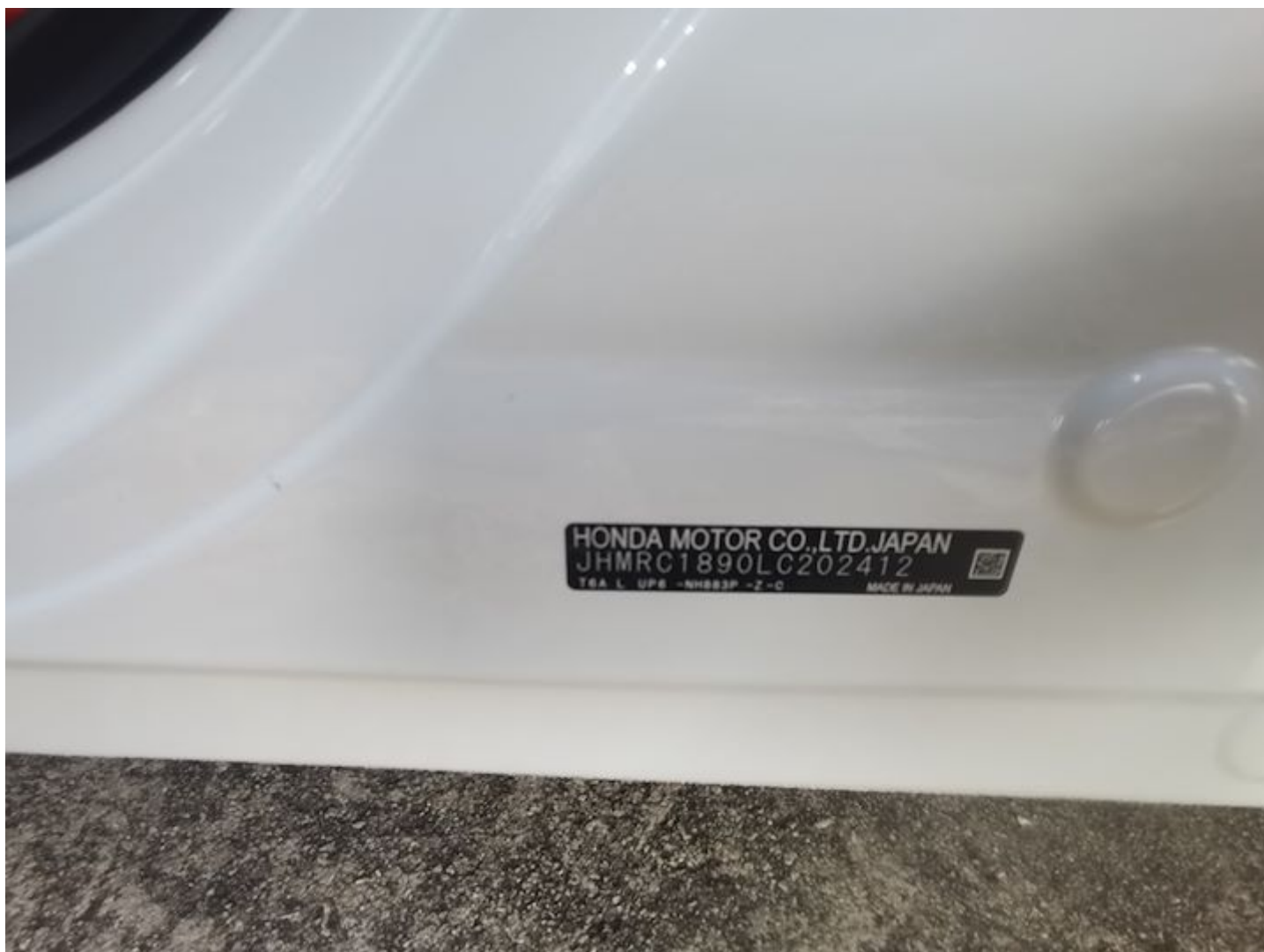
