

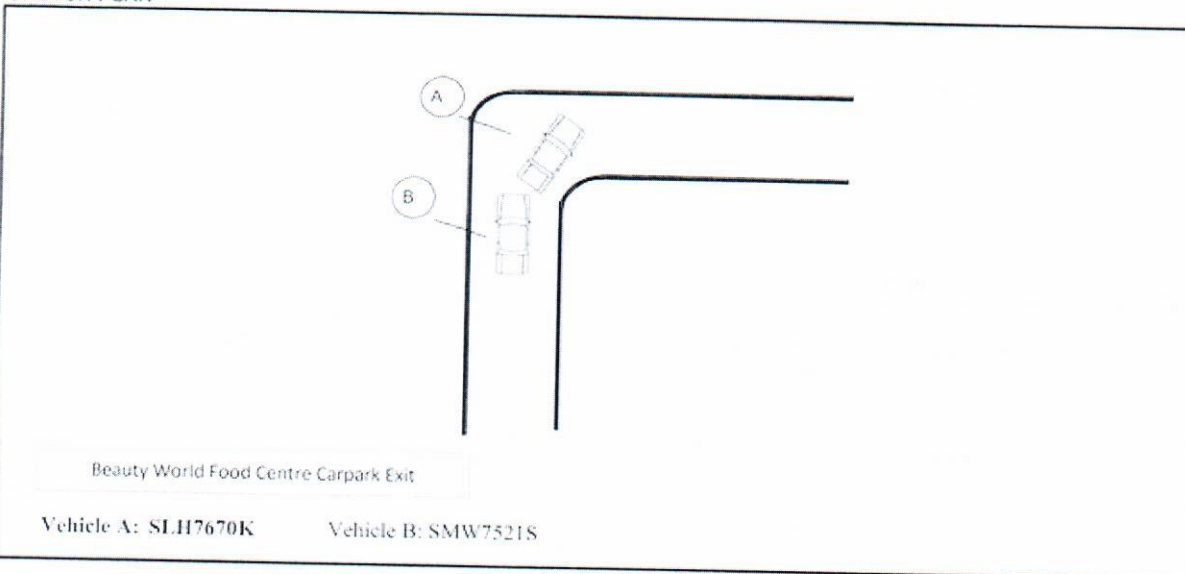

SKETCH PLAN


