




Figure D-3: MID22023 Performing Lane Filtering




Figure D-4: MID22023 Right before Incident





Figure D-5: MID2023 Grazing Incident

### Brief Details.

On 091221, at about 2015hrs, a 6 Ton, MID 22023 operated by 3SG Woo side swiped with a Mitsubishi Lancer SJP6441T (driver under 1 year probation) while changing lane from second lane to third lane along Woodlands Ave 12 after exiting SLE.
