LEASING AGREEMENT (TERMS & CONDITION)

1. The vehicle is restricted to Singapore use only. In the event the hirer wished to enter Malaysia, he/she shall prior to entering Malaysia inform MATCHING CARS SERVICES & sign up for the appropriate insurance & shall be liable to the terms & conditions set out by MATCHING CARS SERVICES.
2. Hirer's Responsibilities:
 - a) The Hirer shall be responsible to pay for the first \$3,000 to \$10,000 damages or cost of repair for each & every accident the Hirer is involved in with the vehicle.
 - b) The Hirer shall be responsible for any loss of earnings by MATCHING CARS SERVICES for the duration the damaged vehicle is undergoing repair.
 - c) The Hirer should note that the Insurance Policy covers only claims from 3rd Parties.
 - d) The Hirer shall be liable for all claims and/or damages arising from the use of the vehicle involving any illegal activity, driving whilst under the influence of alcohol or any other immoral or illegal activity that is not covered by the motor insurance policy taken by MATCHING CARS SERVICES.
 - e) The Hirer shall bear all liability if it is found that he/she had hired the vehicle through fraud, or impersonating or sub-leasing.
 - f) The Hirer shall bear all costs incurred in case of a breakdown for all the parts that are not covered under the Insurance wear & tear, Eg. Flat battery or flat tyre.
 - g) There shall be no replacement of a vehicle in the event of a breakdown.
 - h) There should not be any sub-leasing of the vehicle to anyone during the rental as long as the vehicle is rented from MATCHING CARS SERVICES.

8. The Hirer admits or has sought parental consent before renting the car from MATCHING CARS SERVICES should he/she be below 21 years of age.
