

**Brief Details.**

On the 06/12/2021, at about 0830hrs, I was riding my motorcycle (FR2269M) along upper jurong rd towards PIE going to report to work at Gul Base as Coast Guard. I was riding on the left most lane of a 3 lane road. I noticed that there was a lorry (GBJ9287D) driving on the middle lane. Subsequently, he suddenly changed lane without giving any signal into the Arena Country Club carpark. I tried to break however I did not managed to break in time as the distance between our vehicles was nearby. Hence, I collided onto his front left side of his vehicle and fell.

I immediately called for the police to call for the ambulance as I was suffered some injuries such as chest pain and abrasion on my right arm and a cut on my left palm. I did not managed to get the contact details of the lorry driver however we managed to exchange particulars as I was feeling very light headed. Initially, I asked the lorry driver why he did not turn on his signal when turning into the carpark however he told me he did. Then, when ambulance came, they conveyed me to Ng Teng Fong General Hospital and thus I was given a 3 days MC. Police have attended to my scene and I was given the following report number, J/20211206/0058.

I wish to inform that I do not have a in-car camera on my motorcycle. I was advised to lodge a traffic accident report and thus I am here lodging a report.
