On the 30/11/2021 at about 2130hrs, while I was riding my motorcycle bearing plate number: JNG6961 along the one way road from Eunos Ave 5 and approaching Eunos Road 3 at the cross junction as I was in a right of way as such I did not stopped at the junction however there is a blue comfort taxi driving along Eunos Road 3 did not stop at the stop line and proceed to drove through. As such I pressed on my brakes however I did not managed to stop in time causing my motorcycle to collided on to the taxi right rear bumper area while my motorcycle then hit and fell on the left side causing damages on my front suspension , front wheel and left fairing. After which I noticed that the taxi driver did not stop at the moment and drove off. I then called for police assistance as I was injured on my left elbow, left knee area and the left side of my ribcage area. Subsequently, there is a passer by then witnessed the incident as such the male Chinese witness then assisted to take a photo and showed to me.
