PROPERTY & PERSONAL INJURY CLAIM – CLAIMANT'S NAME: RAZALI BIN RAHMAT ACCIDENT INVOLVING FBK 6276A ON 26 NOVEMBER 2021 AT ABOUT 1955 HOURS ALONG BUKIT TIMAH ROAD (IN FRONT OF MAPLE WOOD CONDOMINIUM)

- 1. We act for Mr Razali Bin Rahmat the rider of motorcycle No. FBK 6276A ("our client") in the above matter.
- 2. We are instructed that on 26 November 2021, our client was travelling along the 3rd lane (from the right) of Bukit Timah Road (in front of Maple Wood Condominium). The said road is a one-way road with five lanes with the Maple Wood Condominium on its left. As there was construction ahead on the 1st lane (from the right) our client decided to filter to the left. When he was in the midst of changing lane to the left, from the 3rd lane to the 4th lane, he was flung from his motorcycle and his body skidded across the road. With the help of passerby, our client was moved to the pavement and was subsequently conveyed by ambulance to Ng Teng Fong Hospital.
- 3. There was short and narrow concrete kerb that had been laid between the 3rd and 4th lanes ("the kerb") that had caused our client's motorcycle to be flung off. A photograph taken on the date of the accident at the accident location shows the kerb clearly. The said kerb appeared to have been recently installed and there were no warning signs or cones placed to alert motorists of its presence.
- 4. On 3 December 2021, we have written to Land & Transport Authority ("LTA") in relation to the above accident. On 13 December 2021, LTA had informed us that PUB was in charge of the improvement works to Bukit Timah canal.
- 5. Therefore, we are instructed that the accident was caused solely by you and/or your agents' negligence in failing to ensure that adequate warning or signage was erected to warn motorists of the "kerb" constructed in the middle of the road, that is, between lanes 3 and 4 of the said road.
- 6. As a result of the accident, our client's vehicle was damaged and our client has sustained personal injuries, suffered losses and damages. We attach herewith our client's Police Report dated 29 November 2021 for your attention.

- 7. We are amidst obtaining the necessary Medical Reports and documents to quantify our client's claim. Meanwhile, please let us have the following:
 - a. Particulars of your agent/s who were in charge of the construction of the kerb;
 - b. Particulars of insurers concerned, including that of your agent; and
 - c. Confirmation on whether you intend to arrange for a pre-repair inspection of our client's motorcycle.
- 8. Please note that if you fail to conduct the pre-repair inspection within the next 2 working days excluding any intervening Saturday, Sunday or Public Holiday, our client's authorised workshop will commence repairs without any further reference to you.
- 9. Our client's rights are expressly reserved. Please let us hear from you as soon as possible.

Brief Details.
Accident report

At around 8pm on 26/11/22. I (RAZALI RAHMAT: ID: \$7242921D) was travelling on my vehicle /motorcycle number FBK6276A along Bukit Timah Rd in front of Maplewoods Condominium at approximate speed of 55-60kmh, i was on the 3rd lane saw road construction works on-site at the far right lane which is Lane 1.

I wanted to make a lane change to my left (lane 4)where it was clear from any traffic/ or vehicles. I Signaled left / check clear/ & pick up with gradual speed.

I did not notice that there was a white plain kerb as it is not demarcted with any black-yellow/black-white painted stripes as the usual kerb. Due to this,the kerb looks exactly just like a white dotted lines lane demarcation as i was on a moving vehicle.

Next moment i realised that i was sent off from my motorcycle flying to the left, sending me dragging across the tarmac road a certain distance. I sustained bodily injuries on left parts of my body & right arms abrasions. My left ankle was injured the most.

Motorcycle was lying flat in middle of the road with groceries plastic bags. Got up & limp my way to safety from oncoming vehicles behing me. 2 passerby assisted to retrieve my scattered items and help to move my bike to the pedestrian walkway to prevent any oncoming vehicles from colliding it.

While laying down waiting for the ambulance to come, i witnessed a grey toyota vios car comes into contact with the same kerb with its front left wheel. Immediately he jammed brake causing the motorcycle behind to crash into his rear left bumper, sending the rider to be flown off his motorcycle.

With this i noticed that the kerb is the main root cause of endangering other road users. Which I personally gave my deep worrying concerned feedback & statement of this danger to the traffic police and EMAS officers that was on site.

Requesting them to immediately close the lane to avoid any further accidents which is in sequence with my supporting evidences.

With this i conclude and personally felt that LTA and their sub-contractors failed to act accordingly to their Safe Work Procedures.

As a patriotic and law abiding 100% Singaporean i am extremely saddened and extremely disappointed by the standard of the site work being carried out by LTA and their sub contractors which I personally believe does not put the safety of other road users and road tax payers as their utmost importance objective while carrying out this project, putting other people lives in danger.

Question here:

1)Why in the 1st place there was

A) No Road "Construction in Progress "signs at the beginning of the kerb
B)safety cones/ beacon blinkers being placed along the kerb to inform/notify road users of the new kerb
works as a demarcation sign instead of just leaving the kerb plain white?

2) Why is the road levelling surface of lane 3 and 4 is of drastic difference in height.

In the very first place, this should not happen at all.

_TA should not wait for fatalities to happen and only then to seriously act upon it.

Please do investigate of this matter which cause the accident stated above accordingly.

Looking forward to the outcome of this investigation.
