CIRCUMSTANCES OF ACCIDENT

AT AROUND 6:30 PM ON 11/12/21. AS I WAS TURNING LEFT OUT FROM TANJONG PAGAR TO KEPPEL ROAD, I WAS ALREADY AT THE YELLOW BOX. I SAW A SILVER CAR STOPPED FOR ME TO TURN LEFT, HOWEVER WHEN I MADE THE LEFT TURN, THE CAR SUDDENLY MOVE FORWARD, HENCE KNOCKED AND SCRATCHED MY REAR WHEEL BUMPER ARCH, CREATING MINOR SCRATCHING ON THE REAR WHEEL RIM AND CAR BUMPER. I RECKONED THE DRIVER. DRIVER MAY NOT BE CONCENTRATING ON THE ROAD AT THAT TIME. IT WAS DRIZZLING AND THE ROAD WAS WET. NO ONE WAS INJURED IN THE ACCIDENT. THERE WAS A LADY PASSENGER. SHE DIDN'T JET OUT OF THE CAR, SHE WAS NOT INJURE AS WELL.






I reckoned the driver (a Grab) driver may not be concentrating on the road at that time.
