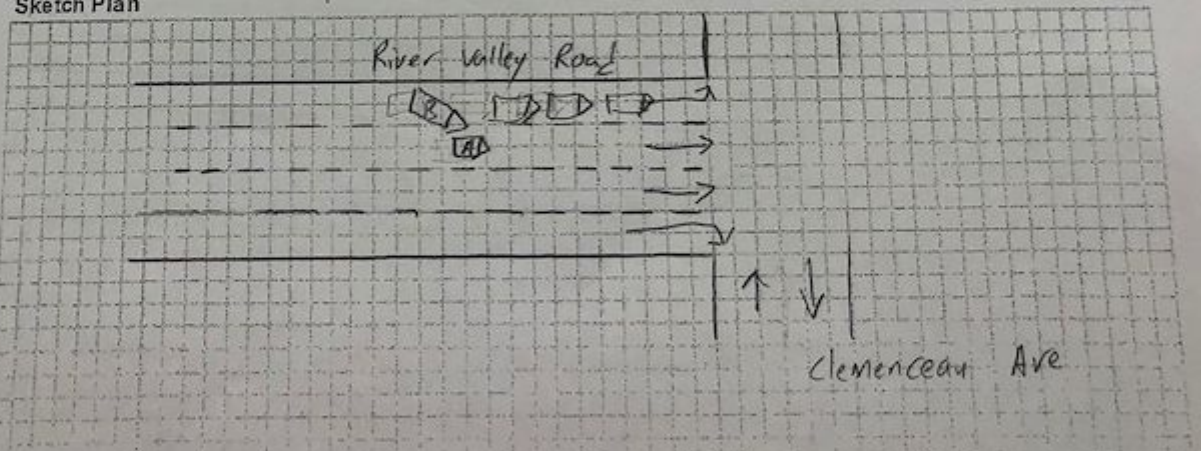




Describe Chronologically the Accident

I am the driver of Car A, SMM4184D, and was driving on lane 3 along River Valley Road on 17 December 2021. It was raining and the road was wet. At about 9.50 pm just before the traffic light cross junction between River Valley Road and Clemenceau Avenue I felt an impact on the rear left side of my car's panel and bumper. I then realized the Car B, SMP7241L, which was on lane 4 did not notice I was travelling on lane 3 and tried to change to lane 3 which I was driving on, causing the collision and impact to the rear left side of my car's panel and bumper.
