

We were making a right turn into Bedok Court. Oncoming traffic was ~~was~~ stalled on the right lane due to heavy traffic and the traffic light junction just ahead. We made a cautious and slow turn into the yellow box, towards the entry/exit of the condo. When proceeding, a car on the left lane then hit us on the side of the car (passenger side). No braking and screeching was heard and the impact was very hard, causing our vehicle to travel and mount the ~~the~~ divider at the condo entrance.
