

Attending surveyor Adrian has brought to my attention regards Insured's appeal despite he has informed her the Left headlamp is not consistent to the accident scenario. I have also relook into this OD Claim and of view aligned with Adrian's recommendation.

From accident scene photo taken, it clearly show Insured's vehicle directly rear-ended claimant' vehicle back resulting a intensive dent on the Tailgate and Rear Bumper. Insured's vehicle model Audi logo (4 jointed circle logo) stamped shaped is visually noticeable circled in yellow on claimant's vehicle tailgate. Should Insured's vehicle is slanted more to the left, Left headlamp will resulted crack from the great impact but the surveyed photos show otherwise. To support my review, the "scratch" mark located at corner of Left headlamp shows identical grazed marked with white residue settling onto the headlamp acrylic and Front Bumper which is parallelly matched as orange arrows indicates. Hence, it is deem to be not consistent.







Kindly inform Insured we have reviewed her case and regret to inform we are unable to accord for the Left headlamp.
