Brief Details.

On 25/11/2021 at about 6.30pm, I was riding my motorcycle bearing plat e number JPA4540 along Woodlands Ave 9 infront of B/773. The light was in my favour and I was already riding beyond the white line at the traffic junction, however as I was going straight, suddenly, a blue taxi from the opposite side started making a U turn ahead of me. I tried to swerve my motorcycle to avoid colliding into him however I still ended up colliding onto the front left side of the car. Due to that I fell off from my motorcycle and was subsequently sent to the hospital. I was admitted from 25/11/2021 to 1/12/2021 and received 50 days of hospitilisation leave.
