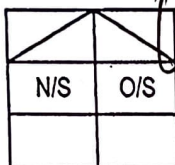

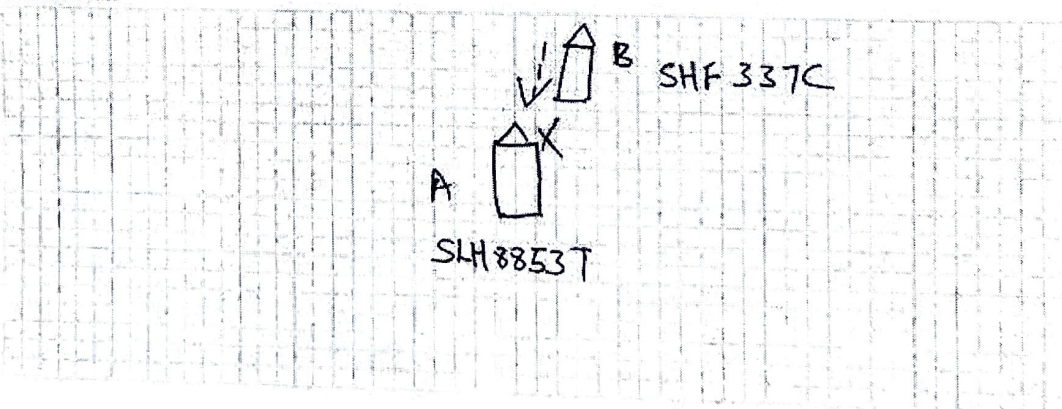

Sketch Plan

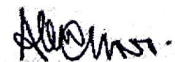

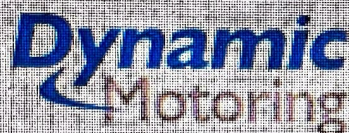
