


Brief Details.

On 26/01/2021 at about 1440hrs, I was on ambulance training driving vehicle MID34780 on the left most lane on PIE towards Tuas. As I drove near Jalan Bahar exit, I noticed that there was a tipper truck which was stopped by a Traffic Police officer on the chevron. When I drove past the tipper truck, the truck top cover opened up and it protruded out into my lane.

Upon reaching my destination, I made a check on my vehicle and discovered there was a dent and some scratches on the top left part of my vehicle. I wish to state that neither me nor my passengers in the vehicle heard or felt any collision with the tipper truck top cover. I checked the in-vehicle CCTV but was unable to get the tipper truck vehicle number.
