According to surveyor:

- 1. The number of days for spray painting the accident portion is 4 days. For the whole vehicle, it should take about 12 days to 14 days.
- 2. Normally, experienced spray painter will do some blending of the colour tone between the un-sprayed portion and the sprayed portion to ensure that the difference in colour tone is not obvious.
- 3. Additional \$1500 is reasonable for spray painting the unaffected parts of the whole vehicle.
