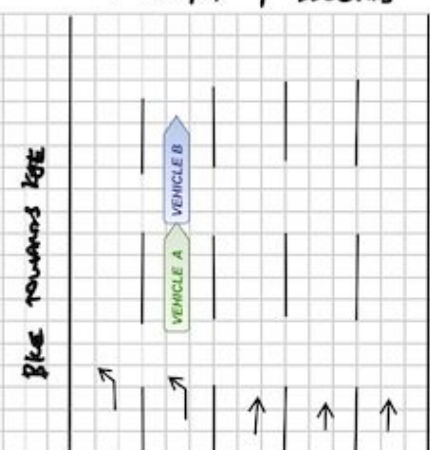
Sketch Plan
