



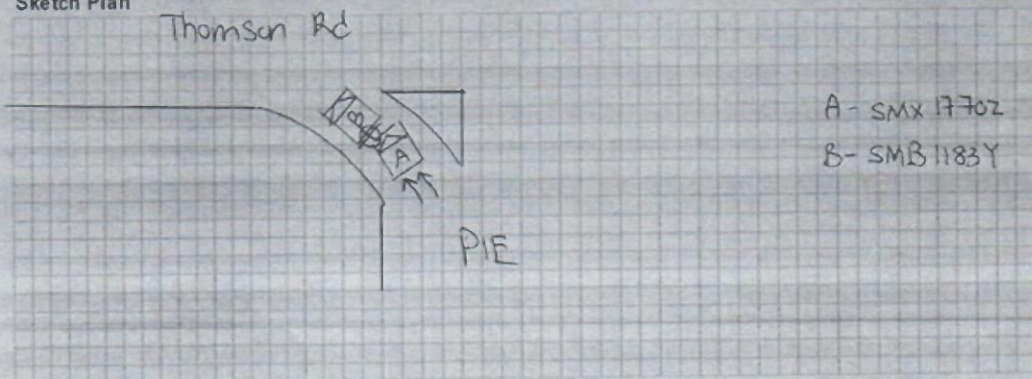

**Sketch Plan**




