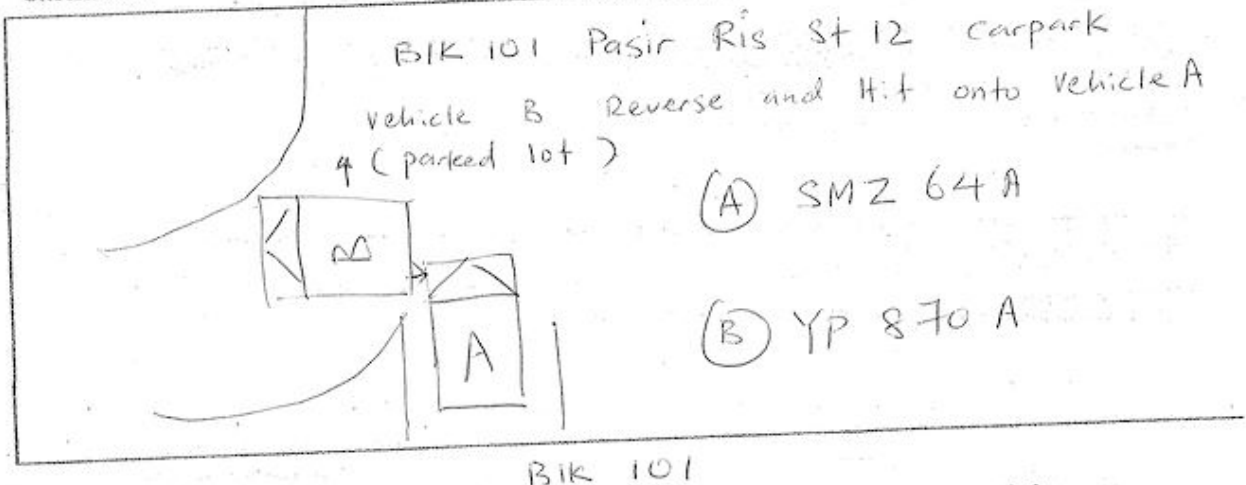

**Brief Details.**

I parked my car (SMZ 64A) on 24/12/2021 at around 1400hrs at the open-spaced carpark of B/101 Pasir Ris St 12, at lot 225 (beside a semi-round curb). When I went down to check on 26/12/2021 at about 1000hrs to buy some things, everything was intact, and my car was in line with the carpark lot.

On 27/12/2021 at about 0810hrs, I went down and wanted to drive my car. I discovered the position of my car shifted to the right and my car was badly damaged with dents on the left. The passenger door on the left was unable to open as well.

I wish to state that I have yet to know whether my car is still working or not. I also wish to add that this open-spaced carpark is a one-way road. I have an in-car camera installed at the front of my vehicle and I am not sure whether it was recorded during the point of time. There was no note on my windscreen and I did not receive any contact number from the third party.




