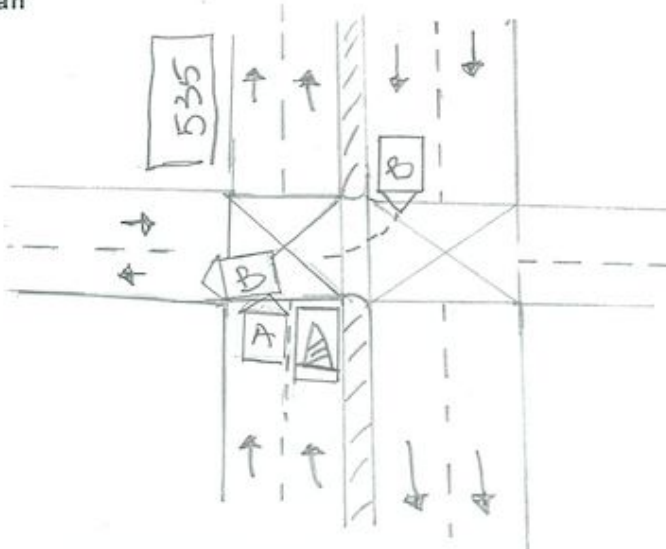

On 29.12.21 at about 2.15 hours, I was driving my vehicle SMM6169K on the left lane of Hougang Ave 8 towards the direction of Hougang Ave 6. When driving near to Block B1535, Vehicle GBC1767A which was travelling from the opposite direction suddenly made a right turn to Hougang St 52 without noticing my vehicle was approaching. As a result the said vehicle GBC1767A collided with my vehicle SMM6169K. At the material time, there was road work in progress on my right side.
