R2000008199 Circumstances Of Accident After I had topped up petrol

I moved my car

getting ready to exit the petrol station. I intended to drive to the lane in the opposite direction of Tiong Bahru Road (heading towards Tiong Bahru Park). In the first lane (the direction towards Redhill Mrt)

there was a stationary lorry (road work) (refer to the video). I slowly inched my car out and waited for traffic in both directions to clear. After I had assessed that the road was clear

I drove out slowly and cautiously after I had signalled my intention. After I had driven the car to the opposite lane

a car suddenly appeared and hit my rim (rear left rim). According to the video

there was no car within sight when I drove out of the petrol station and I was moving at a cautious speed. The driver of the other car would have been able to see my car from a distance but it did not stop in time. It was probably speeding or not looking out for traffic ahead.

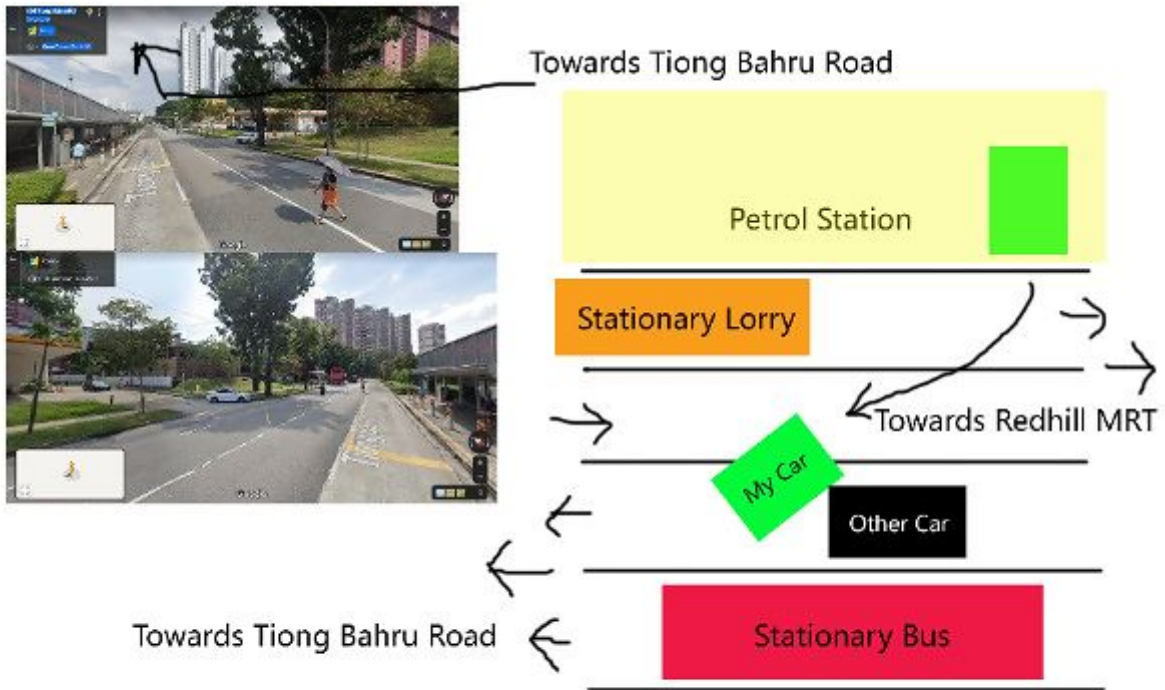
