SO I CAME OUT FROM MY LORRY TO INSPECT AND REALISED THERE WAS A YELLOW CAB (SHC7022E) DID NOT AWARE MY LORRY STILL IN FRONT OF HIM AND TAXI DRIVER DID NOT KEEP A PROPER LOOKOUT AND THEN COLLIDED ONTO REAR PORTION OF MY LORRY. HENCE, I HERE TO LODGE THIS REPORT TO CLAIM AGAINST VEHICLE B (SHC7022E)'S INSURANCE FOR MY ACCIDENT DAMAGES.







Sketch Plan




(A) YN 514D
