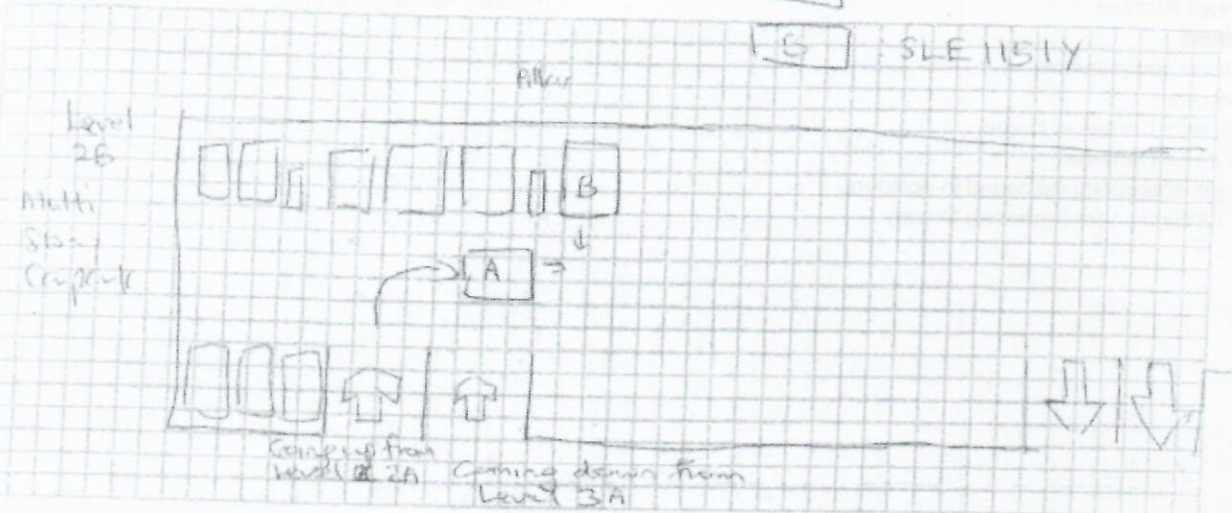

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

02 Jan 2022, and 1220 pm, was entering carpark at Marine Parade Central multi-story carpark.

Was going up carpark from level 2A to level 2B.

From the slope going up to level 2B, there is an immediate right turn.

To make the right turn, driver A (myself) had to turn slow and look carefully on right for vehicles coming on the right. Vehicles coming from the right are vehicles coming from level 3A down.

Was turning right and my head was looking right to watch out for cars coming down slope. There was no vehicles coming down in front of me when I turn right, there was also no vehicles park along carpark lots.

When I turn my head back after looking right, car B (SLE1151Y) had come out of carpark and we had collision.

Driver may have visibility of no car coming down slope but there was also a pillar on his right that could restrict his visibility of my car turning right and moving forward in his direction.

Impact area is his front right bumper and side panel. (SLE1151Y)

Impact area for my car (SQX6628R) is my left bumper and side panel and bonnet.

No one injured, driver B and his passenger. No one injured from driver A and my 2 passengers.
