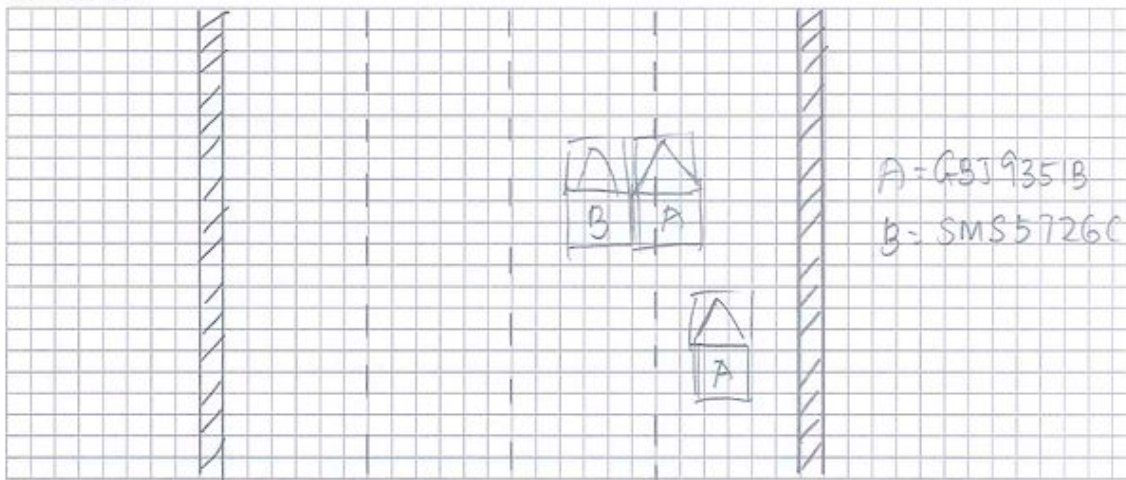

Brief Details.

On 01/01/2022, at about 2000hrs, I was driving my company vehicle, GBJ9351B, along BKE towards Woodlands. As I was approaching the Mandai exit, I was in the first lane.
