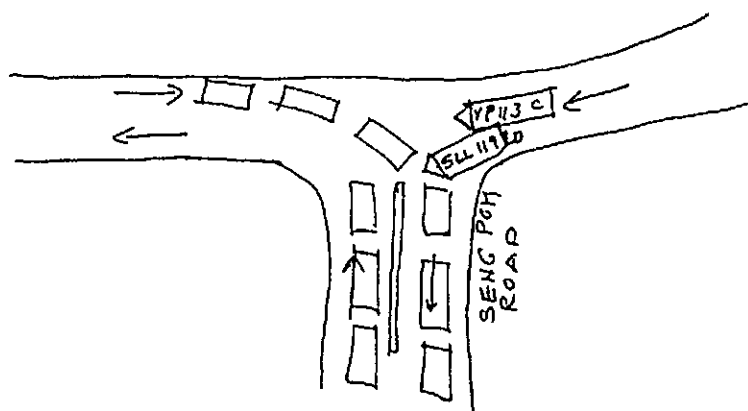

Then the lorry came from behind and as he wanted to change lane to go to the opposite direction, He went past my vehicle and hit my side @ the rear


He admitted his fault and got his boss to text me to apologise and said he will make good the paint work.

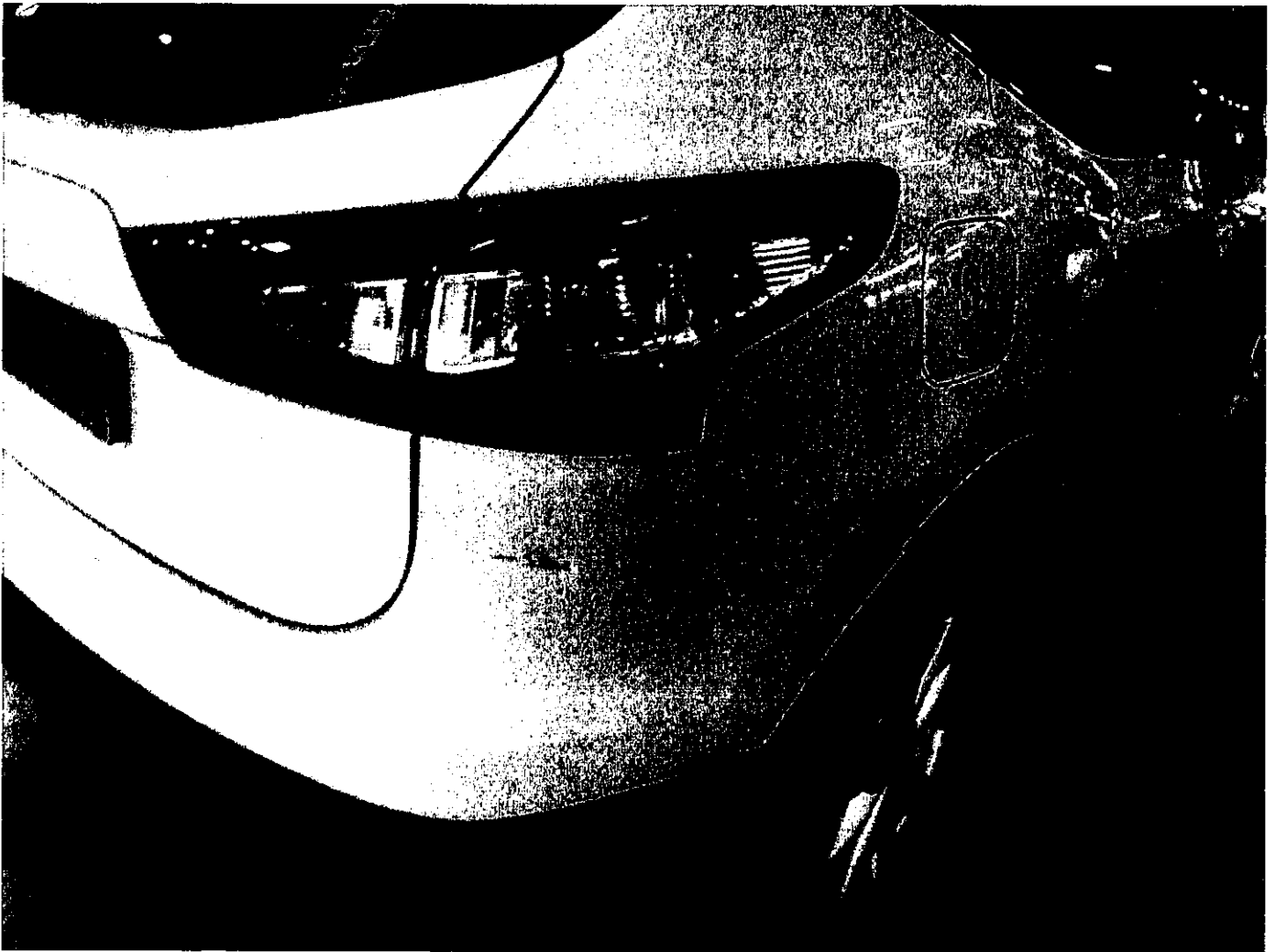

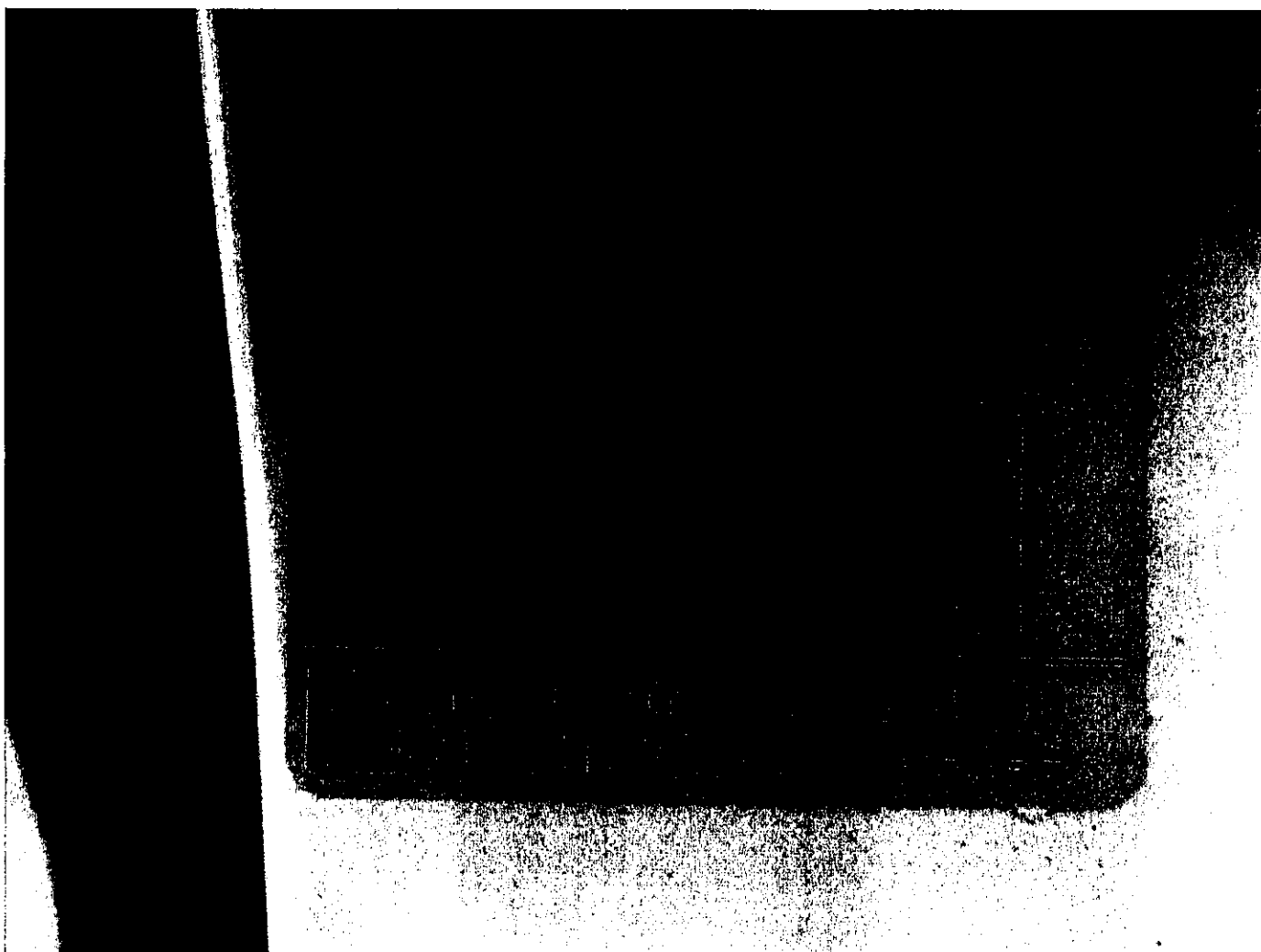
