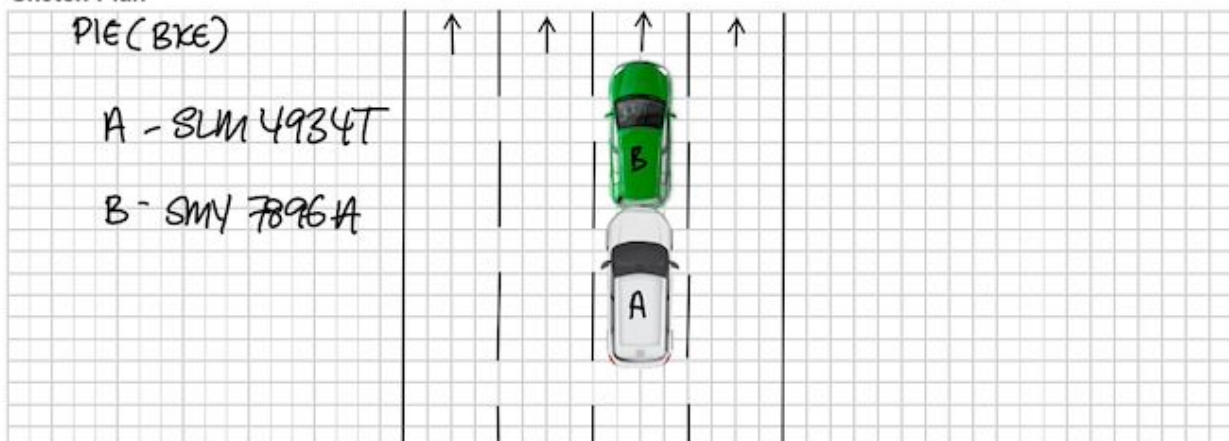


Sketch Plan
