**Brief Details.**

I was cycling along Upper Thomson road towards Macritchie Viaduct, when I passed the vehicle SLA4772G (I have images of the vehicle) that was exiting SLE to Upper Thomson Road. I looked left at the vehicle as I passed, to make sure that he had slowed down to a stop before proceeding. Right after I passed in front of the vehicle I noticed the vehicle's headlights accelerating towards me from behind. At that moment I got rear ended, and was thrown off the bike. While I was on the floor I saw the vehicle pull over few metres in front of me, and the driver MATHANKUMAR S/O KUYMARAN stepped out of the vehicle to check on me. He asked if I was ok and offered to call the ambulance. However, as I didn't know what to do in this situation, and it was a dangerous spot for me and my bike to be laying on the floor (right after the exit from SLE to Upper Thomson Road), I told him to get me and my equipment off the road first. I was hesitant to call the ambulance as I was still conscious and able to walk slowly. At that point the driver offered to give me his physical NRIC so that he could send his passenger home first before returning to settle the situation, I agreed.

I called my parents and explained the situation to them, and they drove over to my location. To make it easier for them to stop, I wheeled the bike to the nearest bus stop further up the road (56089). Before my parents arrived the driver had returned and stopped at the bus stop. He got off the car and gave me his personal details-NRIC and phone number upon my request. I took photos of my bike and his vehicle for record of the incident, and checked if his dashcam was working but he claimed it was not. I was discussing with my parents on the

phone what to do next, and they said to wait for them to arrive first before making any decision. After they arrived, MATHANKUMAR S/O KUYMARAN spoke to my parents and helped me load my bike into the car. Few minutes later, we separated and my parents decided to send me to Khoo Tech Puat Hospital.

I got discharged around 2.30am on 29 Dec 2021, and that was when I searched online on protocol for such an incident. I called 999 and they referred me to Traffic Police to follow up my case. After some back and forth they told me I had to lodge a report online, and hence I'm submitting this at the earliest.
