

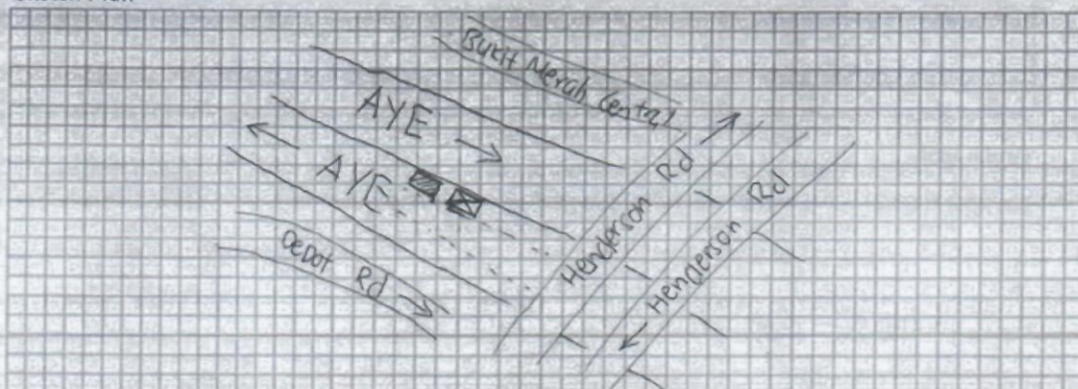



SINGAPORE ACCIDENT REPORT

Describe Circumstances of the Accident

While travelling along AYE (towards TUAS), vehicle SMN7430N was cruising approximately 80km/h on the Lane 1. Vehicle SMK4281S was travelling in front of SMN7430N. At the area along side Depot Road / Bukit Merah, vehicle SMK4281S came to a sudden stop due to build up of traffic and was stationary at that time. Due to sudden braking vehicle SMN7430N was not able to come to a complete stop in time and subsequently collided onto the boot (rear) portion of SMK4281S. Both vehicles suffered damages. Time of incident was 7.11am on 6 Jan 2022. Both vehicles only had the drivers onboard. No injuries was sustained.

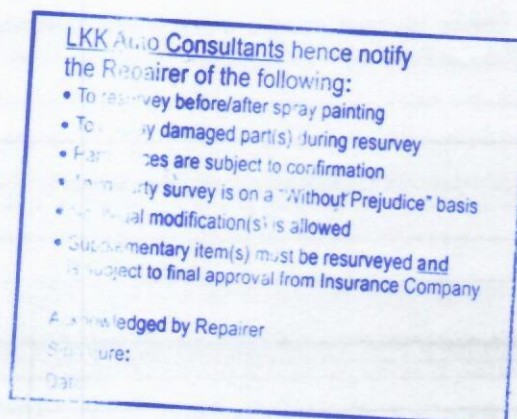
