

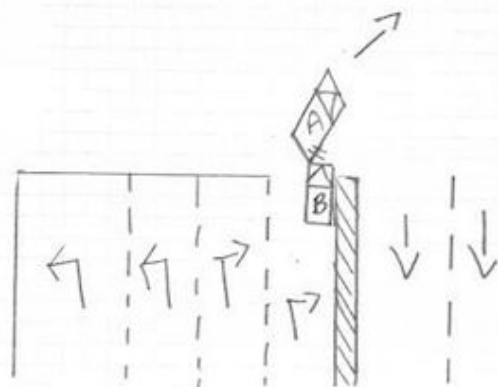

Moulmein Road toward Balestiar Road -




## Describe Circumstances of the Accident
