SKETCH PLAN

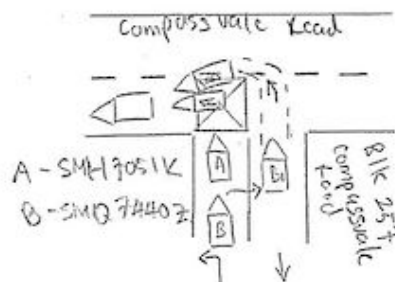
