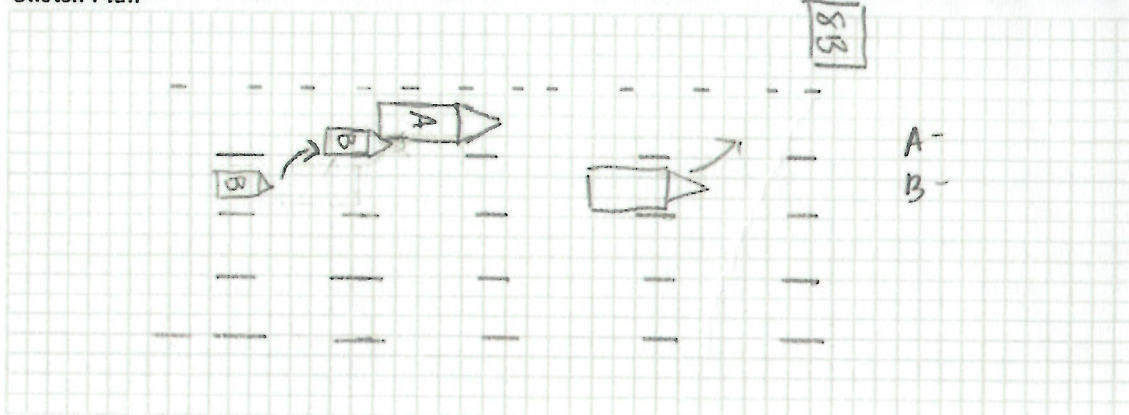

This is to confirm that Timothy Charles Santos Belen, NRIC: S9510176C Contact: 98339676, has reported to the Police a Non Injury traffic accident which occurred along CTE towards PIE on the left most lane before exit 8B near L/P 388.  20/12/21 (20/12/21)

On 20/12/2021 at about 0100hrs, I was driving my car (SFN7691P) along the left most lane of CTE before exit 8B into PIE.
