Dear Sir,

The camera is from your client's perspective and there is no clear marking.
However your client already admitted that he was filtering (see below).

When I was filtering into the right-most straight moving lane at **18:26:14** hours, I had saw that there was a good distance of approximately 1.5 to 2 car lengths in between me and Mei Ling's car for me to begin filtering in towards the right-most straight moving lane with my blinkers turned on (reflected in image B). The distance should have provided Mei Ling with ample time to slow down and be aware of my vehicle filtering into the lane.
