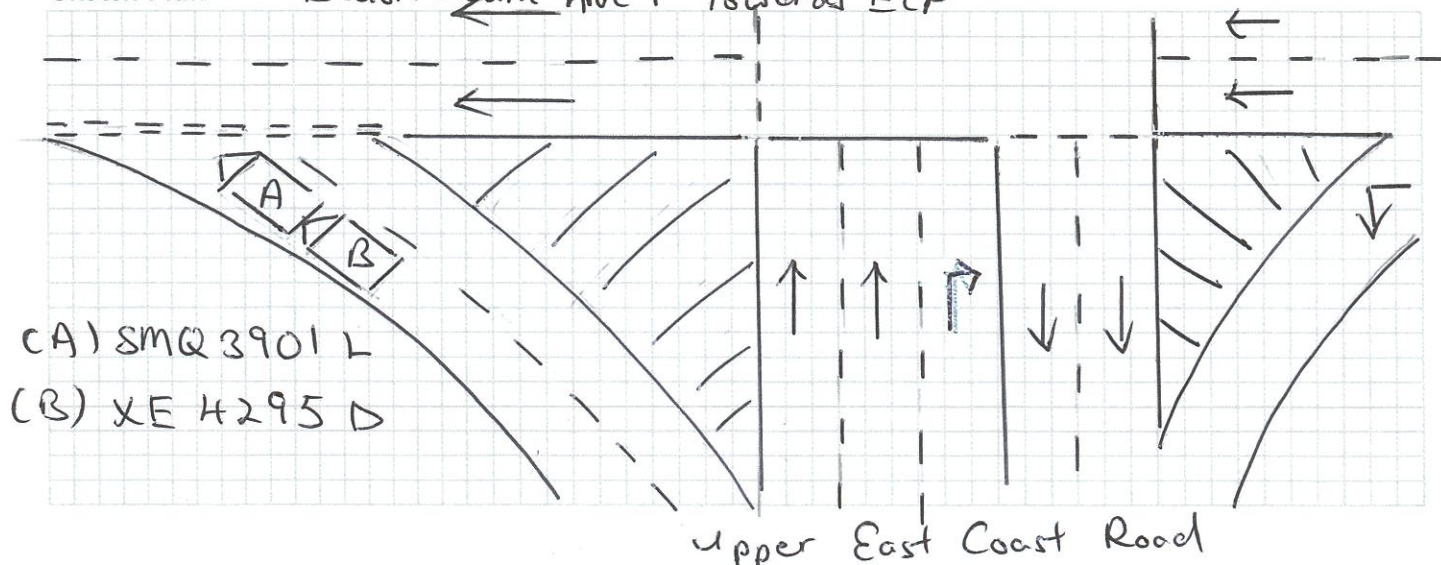

Bedok South Ave 1 towards ECP




Describe Circumstances of the Accident
