

Brief Details.


On 8/1/2022, at about 2230hrs, I was riding my motorcycle JUA3514 within the carpark of Blk 101 - 129 Pending/Gangsa Road, near to the parking zone of Bukit Panjang Community Centre. Whilst travelling towards the direction of Blk 126 Pending Road, I was suddenly hit onto the rear-left side of my motorcycle and fell onto the road. I noticed that a lorry GBB1397P which was parked head-in facing the community centre, had reversed and hit onto my motorcycle as I was passing by. The driver alighted and assisted me.

I rode my motorcycle and followed the lorry driver to a medical clinic (PROHEALTH 24hrs) at Blk 259 Bangkit Road, which the doctor later referred to the hospital. I parked my motorcycle at the vicinity, and the lorry driver then sent me to Ng Teng Fong General Hospital in his lorry. I was given medical certificate for 14 days Hospitalisation Leave, and the lorry driver footed both bills incurred from the medical clinic and hospital. The lorry driver sent me back to my motorcycle and I rode home thereafter.

My motorcycle suffered scratched on the left body area and damaged left side mirror. I suffered injuries on my left hand and leg, and have pending surgery on my left finger. I do not have camera installed on my motorcycle, and am unsure if there are any installed on the lorry.


