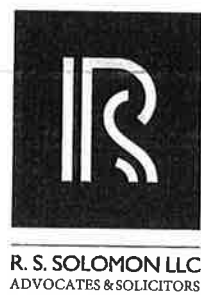

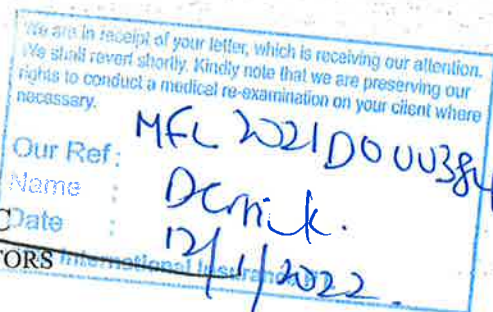
- a) Dr. Lee Soon Tai from Osteoporosis Clinic & Orthopaedic Surgery;
