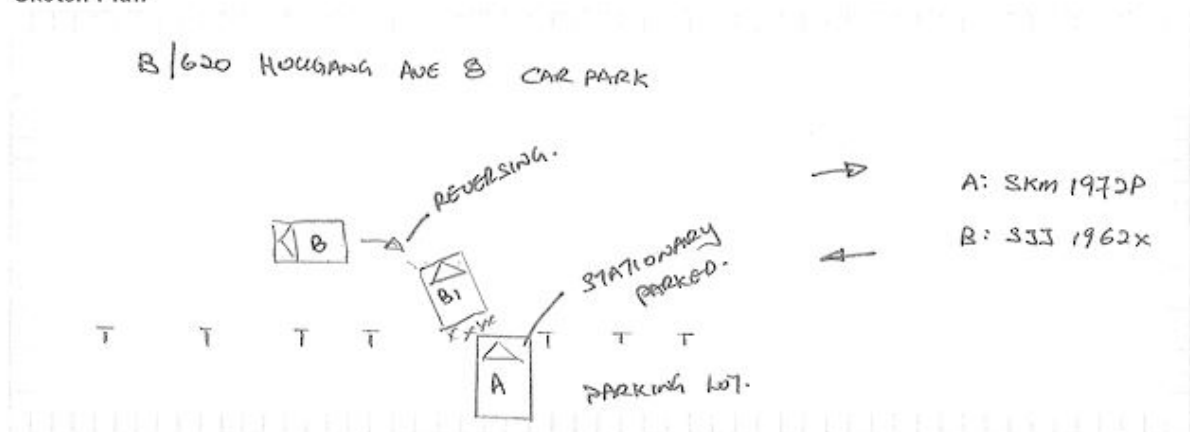

- b. Road tax and radio license
- c. Insurance coverage with an excess of S\$ 2000.00 (for Singapore Usage) for each and every damage and/or accident during the period of rent. Excess shall be doubled for any driver's age less than 26 years old, and/or driving license not more than 2 years. The vehicle shall not be permitted to be driven by any person with age less than 25 years old.

- g. Loss-of-Use Rental Waiver:
 - Half (0.5) Day Rental Deduction for between Eight (8) to twelve (12) hours of Downtime
 - Full Day Rental Deduction for more than twelve (12) hours of Downtime

- h. Maintenance (Due to Driver's Negligence)
- i. Petrol
- j. Traffic offence fines and summons
- k. ERP (Electronic Road Pricing) and parking charges

1. Restricted Driver is applied for this rental. Hirer will be required to furnish additional Named Driver's Details
2. Cash/Cheque is acceptable for all payments. One Thousand (S\$ 1000.00) security deposit and 1-week rental premium will be required, upon signing of this confirmation.
3. The (Hirer) shall be charged the rental fee as set out in **clause IV** to this Agreement (the "[Rental Fee]").
4. **PLATINUM RENTALS PTE LTD reserves the Right to Repossess the Rental Vehicle in whichever way the company deems fit if the Outstanding Rental amount is more than two (2) weeks. In addition, the Hirer will have to bear all the Recovery Costs incurred. The Security Deposit will also be forfeited.**
5. Spray Painting Charges Damage incurred by Hirer will not be more than:
 - 5a. SGD \$130 per panel for Japanese & Korean makes;
 - 5b. SGD \$180 per panel for Continental makes;
 - 5c. SGD \$130 per bonnet for Japanese & Korean makes;
 - 5d. SGD \$180 per bonnet for Continental makes
6. For termination of contract, which would have to be incurred by the said Hirer at any point during the rental period, a penalty clause of full rental premium of remaining period will be chargeable to Hirer. All penalties mentioned do not include the Security Deposit.
7. **Deposit shall be refunded two (2) weeks after return of vehicle, subject to clearance of summons and traffic offences.**
8. The Hirer or the Owner reserves the Rights to terminate this Rental Agreement by giving One (1) Month Notice either by verbal/written.
9. **This is 3 months contract with driver - Hamidon Bin Hashim, If the driver haven't complete 3 months Contract & return the vehicle, our company will change the rental amount to \$364 per week not \$350. The driver should top up the balance to our company.**
