At around 2120HRS to 2125HRS, I was driving on Balestier road towards lavender street. I was driving on the 2nd lane (in the middle). The traffic was slow moving and as I was driving slowly, a yellow taxi (SHC7889X) abruptly cut onto my lane in front of me from the right and as I did not have enough response time to stop as he was so close, his vehicle scraped the front right side of my car near the driver's side headlights. As I honked to alert him that he has hit onto me, we moved to the left side of the road near Zhong shan mall slightly in front of the bus stop. He stopped nearer to the bus stop and so I went to stop in front of him, which was further away from the bus stop to prevent congestion of the area. As I got off, I asked for his particulars in exchange of mine, he refused immediately. He just continued walking to the front of his car to mine taking pictures so I did as well. I only managed to take my car's situation and the front of his car with his car plate. And as I asked for exchange of particulars again, he said, "Why should I give it to you? You can give me yours." I responded that it should be both ways and I already had prepared my driver's license on hand. As he was walking back to his car; I waited for him at the back of my car, he immediately got onto his car and recklessly dashed off very quickly, which almost collided into oncoming traffic and a few cars had to stop and honk him very loudly to warn him. And I just stood there by the side of the road beside my car baffled on his flee. Thereafter I drove off to a safer parking area near Desker road and immediately made a police report on the hit and run incident. Thereafter I went back to the scene and had my statement taken and my car camera SD card was handed over to 2 traffic police officers. Case no: E/20210909/0160. 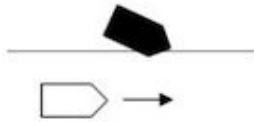

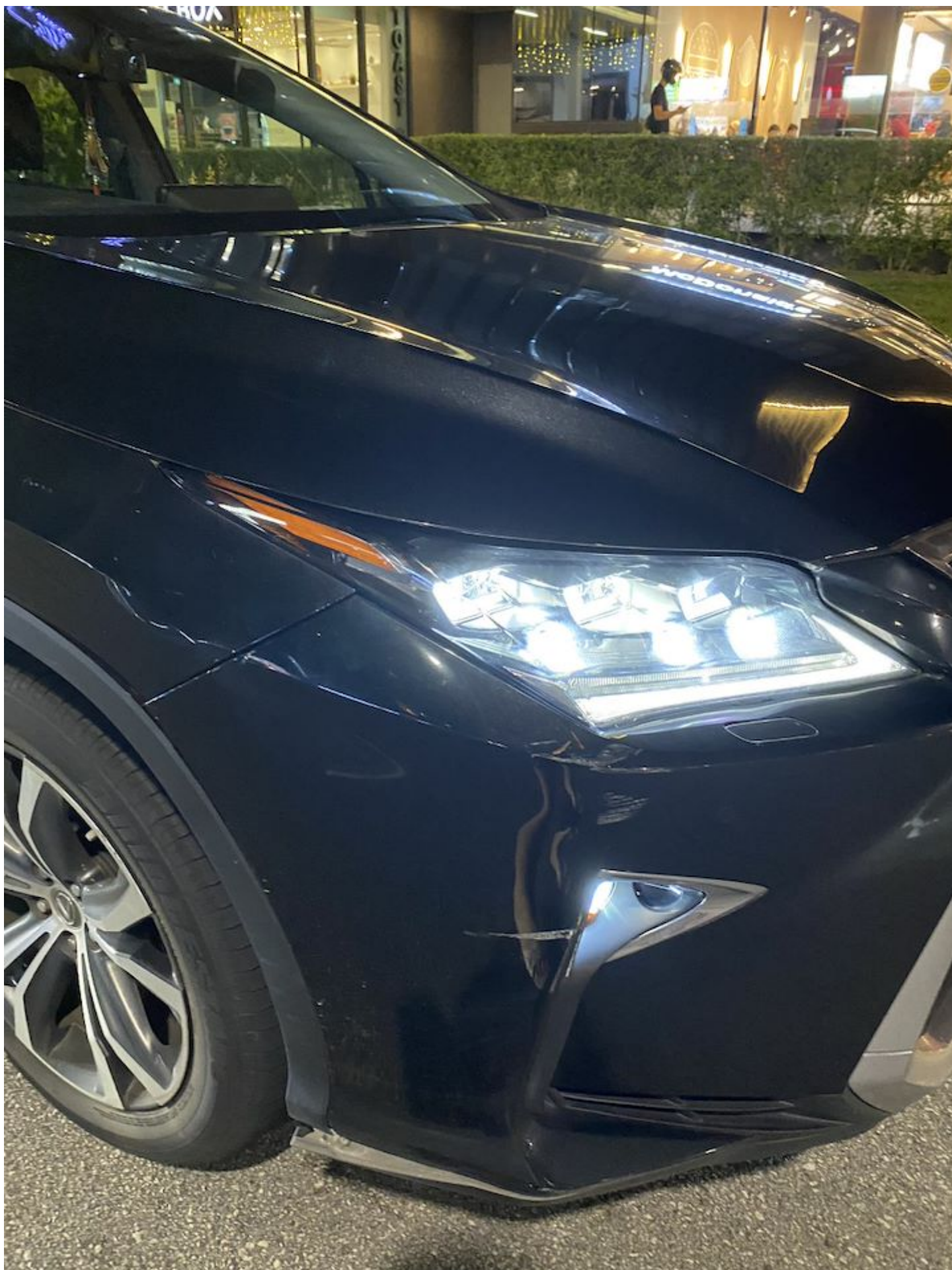
