Describe Circumstances of the Accident

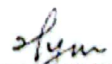
On 13 Jan 2022 at about 1035 pm I was driving in the middle lane of N. 1st Highway at a speed of 60 km/h towards the KPE Exit I saw a car (Nissan SJS1744L) suddenly braking about 5m in front of my car and realised he had collided into the rear of another car (Nissan SKR4114D) in front of his car. I tried immediately to brake my brakes but it was too late to avoid hitting the rear of SJS1744L as her braking action and collision with SKR4114D was too abrupt. After the accident, a female driver of a Toyota SMZ 2410X which was in front of SKR4114D came down and claimed that a car in front of hers braked suddenly for no reason and she collided into that car but then driver of that car did not stop and sped off. She insisted he did that deliberately to cause a chain collision. The driver of SKR4114D said that on seeing the driver of SMZ 2410X brake suddenly he had to brake to avoid hitting her car. After the accident there were several persons appearing out of nowhere claiming they could arrange for repairs at workshops.
