

**Brief Details.**

At the above-mentioned date, time and location, I was riding along Orchard Road approaching junction of Bideford Road. I stopped at the red light next to blue COMFORT DELGRO Taxi (SHB4498R). This taxi was at the lane to my left beside me. Motorists in this taxi lane could only turn left from this junction whereas motorists in my lane can either head straight or turn left. Upon the green light, I turned left heading for Bideford Road. As I was turning, I could see that the taxi was heading straight despite being in the extreme left lane but I could not react on time. The taxi's front collided into the side of my motorcycle causing me to fall off from my motorcycle. I landed on my right hand and both legs. The taxi driver came out to render assistance however I did not take his particulars. I was conveyed by ambulance soon after to Tan Tock Seng Hospital and received 7 days of MC. My friend (Name: Navan / HP: 89013231) came soon after and was attended by a Traffic Police and issued a case card. Due to this accident, I was not able to attend my work last night as such my boss directed me to lodge a Police Report. That is all.
