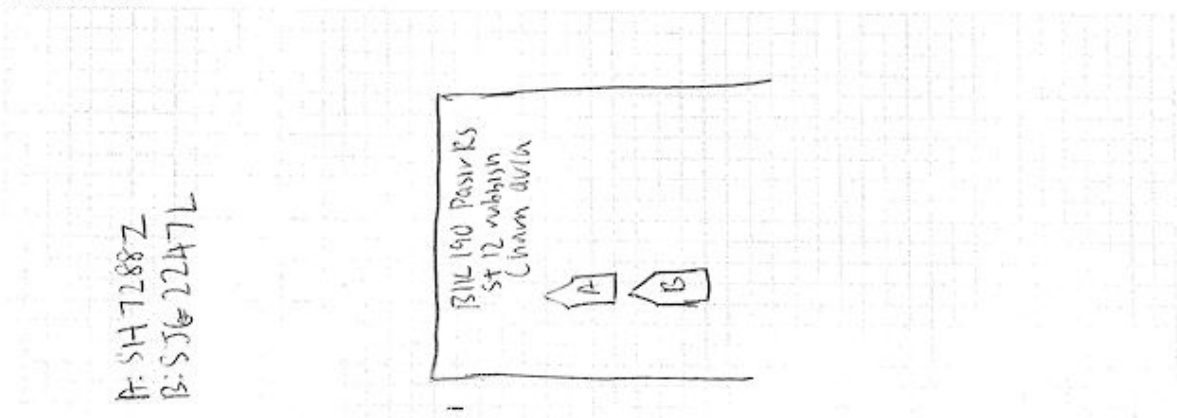

Sketch Plan




Describe Circumstances of the Accident

On 15/01/22 @ 1652H, my Stationary vehicle SJ6-2247L was parked at BIK 190 Pasir Ris St 12 near rubbish chum area. The taxi driver got into his compact taxi SH7288Z and reversed into my car. The entire accident was captured in my installed car camera memory card. Immediately I stepped out and inspect for damages on my car. Initial thought might have no issues, hence the taxi driver left the scene without exchanging of contact information. Subsequently after the taxi left, I did further inspection and noticed my right front head light was not aligned within the car body after comparing with my left front head light. And my car bonnet was not able to close properly.
