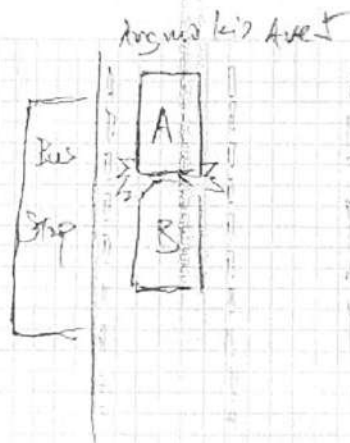

Sketch Plan



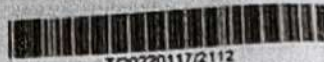

**Brief Details.**

On 17/01/2022 at around 0936hrs, I was driving my white Mazda 3 (registration plate number: SJU2980D) along Ang Mo Kio Avenue 5 on the extreme left lane.
