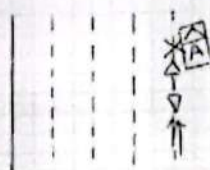

## Describe Circumstances of the Accident

I was travelling along GP (ATE) on 23 Jan 2022 at about 12:40pm. The right-most lane (just before exit 8A). Speed overall was slow due to traffic congestion. I noticed that the lane I was in was piling up and prepared to signal and slowly filter to the second-most lane. I checked my mirrors and blind spot to see no motorbikes at the time. I then signalled and slowly moved left to prepare to slot in behind the vehicle in the second-most right lane. Then I heard a horn and because I did not want to swerve back or do any sudden movement, I decided to stop the vehicle. Then I saw a bike travelling at high speed at my side. I expected to see why there was someone honking, and within a split second he hit my side-view mirror and fell onto the road. My wife and I adjusted the car back straight and went down to check that he was alright. I downloaded the video from the back view camera and saw that the bike had come out at fast speed from behind the vehicle behind me and therefore was not in view when I did my check before changing lanes. There were 3 bikes travelling close together and travelling at a relatively high speed but the 2nd and 3rd bike could come to a complete stop near the rear of my vehicle, along the dotted lines between the two lanes they were travelling on. My vehicle had only moved out slowly with the signal lights, but the bike could not stop in time while travelling at a high speed through congested traffic and was ending up between lanes 1 and 2.
