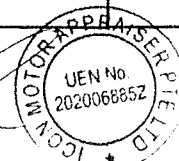

Kindly refer to parts and labour portion for a detailed account of the cost estimates.

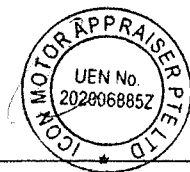
