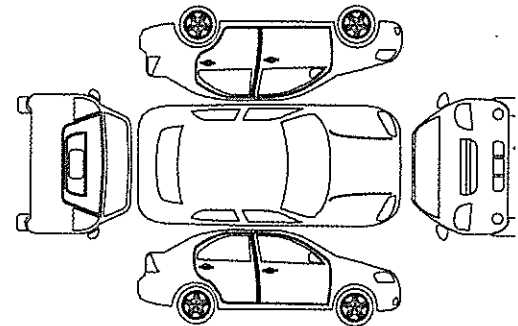

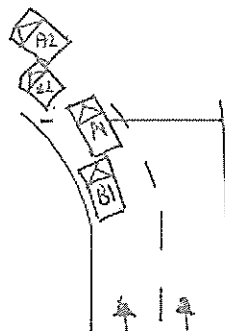

ON THE STATED DATE AND TIME. I, VEHICLE A (SMN4841K) WAS TRAVELLING ON LANE 2 OF JALAN BUROH INTO THE ROUNDABOUT GOING TOWARDS WEST COAST HIGHWAY.
