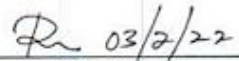

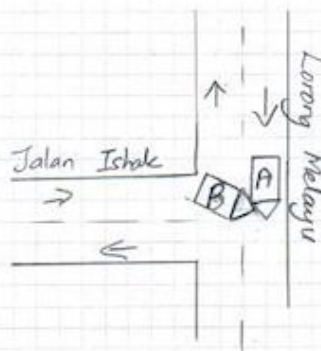

While driving straight along Lorong Melayn, vehicle SK397SS turn out from Jalan Ishtar without noticing me approaching and bang onto me.

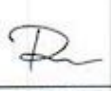
Infront of me got another car which he wanted to ~~drive~~ drive passed but failed to realized that I am behind.
