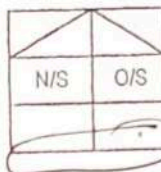

SKETCH PLAN

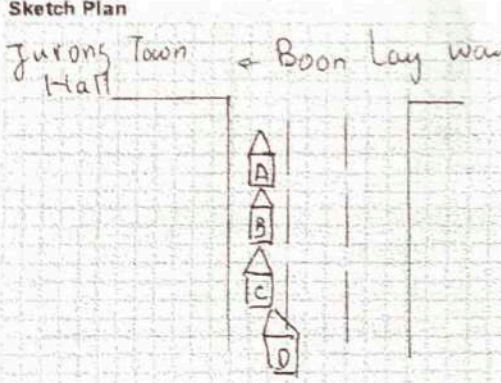
